

# **Discipline Policies**

When entering Twin Cities Academy and Twin Cities Academy High School, students sign a covenant agreement stating that they will comply with the behavioral expectations of the school. To tolerate unacceptable behavior from a few would deny the right of the majority to a full day's education. The following plan has been developed to assist the teachers and school in handling discipline issues in a fair and consistent manner to promote a positive learning environment. It is meant to provide additional direction when initial efforts to improve student behavior are unsuccessful.

It is at the discretion of staff to decide if behavior warrants an infraction. All offenses are reported to administration and documented.

Class Disruption (Talking or Off Task Behavior)

# \*\*Cell Phone Inappropriate Use – Phone taken for remainder of school day

#### Level 2

2<sup>nd</sup> Offense of Level 1 (unless indicated a level 3)

\*\*Cell Phone 2<sup>nd</sup> offense - Phone taken for 5 school days

Persistent Disruption of Learning Environment Refusal To Work As Requested/Insubordination

Nuisance Object Misuse or Distribution

Excessive Tardiness (5+ minutes late)

### Level 3

2<sup>nd</sup> Offense of Any Level 2

Leaving Class or Campus without Permission

Failure to Attend Saturday School

Potentially Dangerous Item Possession Only

2<sup>nd</sup> Offense of Pushing, Shoving, Scuffling – Physical contact that could harm

Trespassing

Photo or Recording Device Misuse

Technology/Telecommunication Misuse

Verbal Abuse (obscene, threats of violence, intimidation, etc.)

**Disorderly Conduct** 

2<sup>nd</sup> Offense of Gambling

**False Reporting** 

Records or Identification Falsification

Harassment/Retaliation (regarding race, color, creed, religion, sex, status, disability, sexual orientation, age, etc.)

Profanity/Vulgar Language

#### ACTION TAKEN AND/OR CONSEQUENCE

Possible Contact Home

**HS**: 3 Infractions = 1 hour Saturday School

**HS**: 4-5 Infractions = Add'l Saturday School hours

**HS**: 6 Infractions = 1 day Suspension

MS: 1-3 Infractions (Level 1 & 2) = Detention (Lunch/Enrichment)

MS: 4 Infractions (Level 1 & 2) = Lose End of Quarter Event

**MS**: 6 Infractions (Level 1 & 2) = 1 day Suspension

Removal from Class Contact Home

**HS**: 1 Infraction = 2 hour Saturday School minimum

MS: See Level 1 infraction consequences

Fireworks Possession, Distribution, or Use

**Breaking and Entering** 

Vandalism (Minor <\$500)

False Fire Alarm

Threatening Group Activity (including graffiti, symbols, hand signs, slang,

tattoos, jewelry, clothes, discussions, etc.)

Medication Misuse (over the counter medications)

Tobacco Use or Possession

Fire Extinguisher Unauthorized Use

Security System Tampering

Theft, Receiving or Possessing Stolen Property

Contact Home Possible Police Contact 3-5 days of Suspension\*\*

## Level 5

Repeated Occurrences of Offenses Listed in Previous Levels

Alcohol/Chemicals Possession or Use

Alcohol/Chemicals Possession with Intent to Sell

Medication Misuse (prescription medication)

Robbery or Extortion

Aggravated Assault

Firearm Possession

Weapons, Explosives, Ammunition, or Other Dangerous Item Possession or Use

Sexual Misconduct

Arson

Vandalism (Major >\$500)
