Finance Committee

- February Financials - Overall good financial report. Brief discussion ensued. Motion to accept February financials made by Varley, second by Howes. Motion carried unanimously.

-18-19 Revised Proposed Budget - Budget includes the following considerations:

- \$100,000 increase for a possible new bus company
- \$ 100,000 reduction from \$200,000 to \$100,000 for curriculum and instructional materials. 17-18 required new textbooks for both math and science. This large of a textbook adoption not needed in 18-19
- \$20,000 increase in budget to add the AVID program, a college readiness program
- Additional salary added to include a full time math interventionist and coach

Motion to approve proposed 18-19 budget moved by LaFleur and second by Howes. Motion carried.

Governance Committee

-Set number of board seats. Currently 8 but recommending 11 total. Motion to approve expansion of board made by Jemielita and second by Holst. Motion carried.

-Discussion regarding upcoming board elections. The bylaws indicate the board endeavor to be one third community members, one third parents, and one third teachers. Applications for board membership were sent to the governance committee. A motion to approve the slate of candidates was moved by Holst and seconded by Jemielita. Motion carried unanimously.

-Update from Dana Peterson of UST informing the board of TCA's charter renewal for 5 years. The longest possible renewal.
