TSO CAI RAU KEV TSWJ SAIB XYUAS MINOR: Kuv tau txheeb xyuas cov ntaub ntawv txog cov kev pheej hmoo thiab txiaj ntsig Pfizer-BioNTech COVID-19 Tshuaj tiv thaiv nyob rau ntu 2 saud thiab nkag siab qhov txaus ntshai thiab cov txiaj ntsig. Kev muab kuv qhov kev pom zoo hauv qab no, kuv pom zoo tias:

1. Kuv tau nyeem daim ntawv pom zoo no, thiab kuv nkag siab tias "Daim Ntawv Qhia Cov Lus Qhia rau Cov Neeg Tau Txais thiab Cov Neeg Tu," suav nrog cov ntaub ntawv ntxaws ntxiv txog cov kev pheej hmoo thiab txiaj ntsig ntawm Pfizer-BioNTech Tshuaj Tiv Thaiv-19.
2. Kuv muaj txoj cai los tso cai rau tus menyuam muaj npe saum toj txhaj tshuaj nrog Pfizer-BioNTech COVID-19 Tshuaj Tiv Thaiv.
