## **Q-Comp Summary Report**

Discussion: Required to be present to school board. TCA won't have the standardized testing scores until mid-August. There was good growth but not proficiency. Holst asked about implications of not meeting proficiency, Lueth responded it's unsure. Becken said there will hopefully be more understanding coming off this year. Lueth mentioned kids slipped back so not only did they not move forward there was the additional trauma associated with the pandemic. It was noted that teacher's did not get the portion of the MCA proficiency for Q-Comp.

#### **Director**

Lueth gave an enrollment update that there are 515 students which is on budget. Marketing is putting out Google ads in Karen, Hmong, Spanish and English. Enrollment is trying to keep the rolls clean. August is a big month for movement both in and out. There are 10 potential applications pending. She feels like TCA is in a good place. Becken mentioned SPPS is putting \$\$ into marketing and that charter schools were their biggest attrition. He wondered if TCA was doing something new to which Lueth replied that TCA missed their 20th anniversary due to the pandemic but she wasn't positive of anything new happening. Enquist said her feeling was like the culture and vibe of TCA was positive and students felt pretty good about TCA this year. No elections happened due to no openings at that time. Lueth mentioned she plans to make a binder for new board members; she did say she needs help with recruitment of board members. Becken suggested reaching out to Hmong/Karen groups and setting up at some local community festivals to pass out information on TCA.

#### **Board Members**

O Becken asked the question about high education for our graduates and where our class of 2022 was at. Lueth usually has that number but this year the focus was for the 15 students who were non-graduates and getting them caught up and graduated which is something that has not happen in TCA history. Enrollment is pretty open in 6, 7, 8 and 10<sup>th</sup> grades while 9<sup>th</sup> grade is pretty full right now.
