Annual Board Training – Jenny Abbs presents Bond Re-Financing and Finance Training

Action Items

- IOwA (Identified Official with Authority) Board Resolution
 - Every year MDE requires we appoint a main person to be the IOwA. A
 motion to appoint Betsy Lueth as the IOwA was made by Enquist and
 seconded by Dennis. Motion carried.
- Bank Signers Update for 2025-2026 Approval
 - A motion was made to assign board chair, Rich Holst, and Executive Director, Betsy Lueth, as the bank signers for 25-26 was made by Karen and seconded by Adam. Motion carried.
- Graduation Requirements Revision
 - Advisory is changing to seminar and increasing skills taught. Proposal to have seminar be 1 credit per year versus .5 credits as it has been. This will be included in the elective credits. Discussion ensued. A motion to accept the new graduation requirements to include 1 credit per year for seminar was made by Adam and seconded by Enquist. Motion carried.
- Reimbursement Resolution (Bond Re-Financing document)
 - This agreement states that TCA will pay back the bonds. Discussion ensued. A motion to accept the reimbursement resolution was made by Dennis and seconded by Aida. Motion carried.
- Maximum Bonding Amount Resolution (Bond Re-Financing document)
 - A motion to approve Betsy and Rich to sell the bonds and not exceed 15M was made by Karen and seconded by Enquist. Motion carried.
- Bylaws Revisions
 - Craig Kepler, our attorney, recommended changing a few lines in the bylaws. All changes are in red in the board documents. Discussion ensued. A motion to approve proposed revisions was made by Adam and seconded by Enquist. Motion carried.
- 2025-2026 School Board Calendar
 - O Upcoming board meeting dates for 25-26 school year were proposed. Starting August 1st, a board member may attend a meeting via zoom without publicly announcing their physical location by way of a new law change. Propose to also move November date to November 18th due to holiday. A motion was made to accept the board meeting calendar was made by Dennis and seconded by Enquist. Motion carried.
